Item 8.01 Other Events.

As a result of the cumulative effect of (1) the cash dividend on common stock declared by the Board of Directors of The Interpublic Group of Companies, Inc. ("IPG" or the "Company") payable on September 20, 2012 to holders of record as of September 6, 2012, and (2) the IPG common stock cash dividend paid on June 22, 2012, the number of shares of IPG common stock into which the Company's 5¹/₄% Series B Cumulative Convertible Perpetual Preferred Stock (the "Series B Preferred Stock") may be converted has been adjusted in accordance with the terms of the Series B Preferred Stock.

The applicable conversion rate for the Series B Preferred Stock has been adjusted as follows:

The conversion rate with respect to the Series B Preferred Stock is the number of IPG common shares into which each share of Series B Preferred Stock may be converted, which as adjusted represents a conversion price of approximately \$13.12 per conversion share.

The conversion rates with respect to the Company's 4.75% Convertible Senior Notes due 2023 have not been adjusted since June 2012 because the applicable threshold before adjustment is required has not been reached.
