Item 9. Sales of Equity Securities Pursuant to Regulation S.

On December 22, 1998, The Interpublic Group of Companies, Inc. ("Interpublic") sold 82,472 shares of its common stock, par value \$.10 (the "Shares"), to one non-United States individual ("the Sellers"), as a portion of the first installment, valued at \$5,538,488 out of a total downpayment of \$7,471,478 to the Seller for 40% of the issued shares of capital stock of Promoseven Network, Inc., a British Virgin Islands international business company.

No underwriter or placement agent was used in connection with the sale of the Shares.

The transaction was effected in an "offshore transaction" and in accordance with the "offering restrictions" and "no directed selling efforts" requirements of Rule 903(c)(2) of Regulation S under the Securities Act of 1933.
